Treasurer's Report: Lauren Patt-Kirby. \$141,774 revenue, \$135,751.50 from dues, \$6,022.50 from miscellaneous income \$95,012.31 in general account, \$5,199.66 playground account, \$1,832.91 pond restoration account, \$3,567.20 in the fire department account, \$1000 petty cash debit card account, \$500 cash at hand, and \$146,293.39 in the reserve account. Ed Wells moved to approve, Seconded by Mike Mumford. Motion carried.

Manager's Report: Clint Malburg. One of the projects this year will include the removal of thistle near the runway. Clint asked for volunteers to help with this project.

Introduction of Candidates & Voting Procedures. There are four openings. Statements by candidates Chuck Harvey, Cynthia Holland, Mike Mumford, and Lauren Patt-Kirby.

Recognition of Outgoing Board Members. Outgoing Board members Lauren Patt-Kirby, Jane Lewis, Ron Anderson, and Cheryl Case were thanked for their service and presented with plaques.

a. Financial Report - Lauren Patt-Kirby. We were over budget on dust abatement but on budget overall.

b. Reserve to Preserve – Lauren Patt-Kirby. The study was done in 2017, we are 82% funded. c. Status of Collections/Liens – Lauren Patt-Kirby. There are 32 lots past due, this is 25 lot owners. Past dues are \$28,286.50.

a. General Update – Paul Placek. A lawsuit is still pending.

a. Roads, Parking, Runway & Facilities – Clint Malburg. Two planes have used the runway. 65 tons of mag chloride and over 200,000 gallons of water were put on our roads. In June the bathrooms were vandalized. Clint proposed installing locks with keypad access, the code # would be included on the fish permits.

b. Pond & Fence – Clint Malburg. Utah is a 'fence out' State. He and Bob Chapman did repairs to the barbed wire fence, saving our Association \$4,900. The pond was stocked in May with 800 pounds of fish, in June with 400 pounds. Clint was able to negotiation a reduction in the cost for fish from \$5 per pound to \$4.25 per pound, and a reduction in the delivery cost from \$225 per delivery to half that cost.
