Word from the Barn

Treasurer's Tell

The 2019 budget was approved with total revenue of \$151,665.00 with \$3,675.00 being transferred to the reserve to preserve at the end of the year.

As of June 30, SCPLOA's total income is so far is \$145,643.50 with the majority coming from dues. The profit is \$65,351.65 but we still have expenses to be paid through the rest of the year.

There was the amount in the following accounts:

General: \$130520.68 Playground: \$5,199.66 Pond Restoration: \$1,832.91 Fire Department: \$5,688.62 Petty Cash/Debit Card: \$697.13

Cash on Hand: \$500

Reserve to Preserve: \$151,700.03

We are on track to meet the budget.

Fees are going Up and Down?

Yes, Western Kane County Special Service District is raising and lowering our fees for the dumpsters.

Current rates are \$50 per lot, per year. Fees will change in November as follows: For lots with improvements as designated by Kane County, fees will go up to \$85 per year. For lots without improvements as designated by Kane County, fees will go down to \$15 per year. This fee is included with our annual tax bill from Kane County.

Do you have a sofa, mattress, or other large item to throw away? They can now be put in the roll off container at Strawberry, it's less than ¼ mile from Highway 14. Or, items can be taken to the landfill south of Glendale, near milepost 88 on Highway 89. Summer hours are Monday, Thursday & Friday from 1pm to 6pm, and Saturday from 10am to 6pm.

They would like to know if you see any businesses or contractors dumping. Call (435) 644-5645, ext. #3 to report the name of the business, the date and time and types of items dumped.

Our dumpsters are for household use, no construction items, and please... do not leave items on the ground!

Fire Safety | CMFPD Update

With the wet winter we experienced this last season not everyone is overly concerned with wildfire right now. The grass is tall and green in our meadow and there is plenty of water in our streams and pond. The problem is that our fire season while postponed is rapidly approaching. In fact it is already here. Fuels are drying out and the fire danger while not extreme is getting higher.

Firewise is a program that home owners can adopt to lessen the impact of wildfire. Fires will occur due to human caused incidents as well as natural caused incidents that are often caused by lightning.

With Firewise, the immediate zone is the area around a structure from 0-5 feet out. This is defined as a non-combustible area. That means that the ground should be down to mineral soil with the ground cover being noncombustible like gravel or rock. Clean roofs and gutters of dead leaves, debris and pine needles that could catch embers.

The intermediate zone is from 5-30 feet out from a structure and while walkways and driveways help to create fire breaks, it is important to limit or remove ladder fuels for the trees in this area. Always clear vegetation away from propane tanks and try to have a crown spacing of eighteen feet between groups of trees. Small groups of tree crowns are great but when the tree crowns extend across a large area it allows for fire in the tops of trees to spread.

The extended zone is from 30-100 feet and out to 200 feet on larger lots. Remove dead vegetation and accumulation of debris. Tree crowns between 30 and 60 feet away from the structure should have a spacing of 12 feet and tree crowns between 60 and 100 feet from the structure should have a spacing of 6 feet.

This is just a snapshot of the firewise program. For more detailed information you can look at the annual newsletter distributed by our fire department or stop by the station and gather information. A firewise property will allow our firefighting force the time to gain control on the fire once it occurs. Fire safety is everyone's concern and by becoming a firewise resident you not only help yourself but you help your neighbor and in effect the entire community.

I'd like to thank you in advance for doing your part in the conservation of our mountain community.

As these are received, and they must be in writing not via social media or in passing while walking your dog, they will be handled on a case-by-case basis. If the complaint is valid and the property is deemed in violation, a letter will be sent and the process followed until the violation is corrected.
