

Explanation of Annual Dues for 2023

For the Association to continue to operate and meet our obligations, it is necessary for annual dues to remain at \$205 for 2023, with no credit issued. When lot owners voted to increase dues by \$80 beginning in 2011, there were 804 dues paying lots. Since that time, Kane County has approved over 100 lot joinders in Swains Creek Pines. It is estimated that we will have only 690 dues paying lots for 2023.

In 2018 in response to lot owner concerns, a second on-site manager was hired in order to have 7 day a week coverage with more access and to protect our pond and other facilities. This year, as BIDR begins construction on the adjacent development, we are preparing for increased activity and the need for more security, and enforcement will be essential

A professional property management company was also hired in 2018 to provide accounting and administrative services. These services are necessary to reduce risk to the Association and assist the board in adhering to state laws and accepted accounting procedures for community associations. Legal services are necessary to review and update our aging governing documents in keeping with state codes. Management and legal services, utilities, insurance, fuel, and property taxes have significantly increased over the past 12 years. However, the budgets have not kept up with the costs of operating and properly maintaining the assets of our Association.

In addition, the Reserve to Preserve contributions have been a small fraction of what was recommended for each year. The most recent Reserve Study indicates our reserve account has dropped to 63% of the recommended amount of funding. It is not only in the best interest of lot owners, but Utah law requires that we adequately fund our Reserve to Preserve account. Per the Reversionary Agreements with the original developer, we also have an obligation to properly maintain our assets. In order to do so, we must increase the budget to include sufficient Reserve to Preserve funding. We appreciate your understanding.

Last year's fire season was relatively mild compared to previous years due largely to the return of the Monsoon rains. The Color Country Interagency Fire Center (CCIFC) had issued a Stage 1 restriction alert early last year, but never progressed to a Stage 2 alert and eventually cancelled the Stage 1 alert. We did have several lightning strikes that resulted in fires, but they were all quickly controlled. Unfortunately, we also had several wildfires that were directly caused by campers not following the rules, and common sense, allowing their campfires to escape and igniting the surrounding wildland. These were reported by other campers in the area, and we are very grateful to those who act responsibly. All were extinguished with help from our Color Country friends. Last year, the completion of a study and review of our ISO rating was conducted. Please contact Station #1 at 435-682-3225 for more information. Looking forward, please be mindful that the mass amount of moisture from the winter creates a lot of brush, which can potentially be susceptible to wildland fires.
