## VII. NEW BUSINESS - DISCUSSION & POSSIBLE ACTION:

a. Fishing Limits on Ballot.

Current fish limit is 5 per Lot per day. The cost of planting fish is \$7 per pound plus the delivery fee. Several Lot Owners asked to reduce the fish limit. This year the annual ballot includes the option for Lot Owners to vote to reduce the number of fish that can be removed to 3 or 4 per Lot per day, or to not reduce the limit.

Lucas asked for additional road base and or leach rock for the muddy area in front of the barn, not to exceed \$1,200. The County still intends to install a culvert and box at the end of the season. Devon moved to approve getting road base/leach rock, not to exceed \$1,200. Lisa seconded. Motion carried.

Our Assistant Manager has resigned. Lucas will work extra hours to provide coverage and could use help. We will recruit for an Assistant Manager for next year.
