# SCPLOA BOARD MEETING MINUTES July 14, 2018 Swains Creek Pines Barn

# 1. **Welcome & Introductions**: Paul Placek, Chairperson

The Meeting was called to order and held at the SCPLOA Barn at 10:03 a.m. MDT by Paul Placek, Chairperson. Paul introduced all Board members present: Charlie Duvall, Vice-Chairperson; Lauren Patt-Kirby, Treasurer; Jane H. Lewis, Secretary; John Colman; Ron Anderson, and Cheryl Case. Clint Malburg, Property Manager. Dan Theisen was excused and gave his proxy to John Colman. David Pugh was excused and gave his proxy to John Colman and Amanda Crosby, CAM, SCPLOA Management Company representative was excused.

# 2. Secretary's Report & Approval of Minutes: Jane Lewis, Secretary

The proposed minutes from June 16, 2018 SCPLOA Board Meeting were respectfully submitted.

Lauren Patt-Kirby motioned to accept the minutes as read. Ron Anderson seconded the motion.

### 3. Review of Executive Committee: Paul Placek

Paul reviewed the Board Executive Session held prior to the Open Meeting. The Board discussed road signs and the mandate from Kane County for address signs. Lot Owners were advised to take down their lot numbers, it they are still visible. If one does not know their street address, it can be found on their tax statement or on Kane County website. It was noted, there are about thirteen lots that do not have an address, and Kane County will deal with the issue when the lots are developed. The Pond will not be stocked again unless the water levels increase. Play Ground funds were evaluated. The teeter-totter became unsafe and needed to be removed. A committee was assigned to look into replacing the equipment. Cabin rentals have increased and if one wants to change the ordinance, the CC&Rs will need to change. Individuals that decide to take on this endeavor will be given guidelines of the procedures.

# 4. **Treasurer's Report**: Lauren Patt-Kirby, Treasurer

As of June 30, 2018, the total income so far is \$138,908.00 with \$134,868.50 coming from dues. There was \$116,114.11 in the General Account, \$5,199.66 in the Playground account, \$1,832.91 in the Pond Restoration account, \$2,925.23 in the Fire Dept. account, \$1,000.00 in the Petty Cash-Debit Card account, \$437.50 in Cash on Hand and \$146,225.08 in the Reserve to Preserve account.

Motion to accept the Treasurer's Report was made by Cheryl Case. Charlie Duvall seconded motion.

### 5. Manager's Report: Clint Malburg

Clint stated the Stop, Shop, and Swap had a large turnout with 32 tables reserved. The next event is the Spaghetti Dinner, [Saturday, August 11]. Clint reminded everyone the area is still under fire restrictions – no campfires, no chainsaws, and log splitters after 1:00 p.m. Clint and Bob are painting street signs. He said they have finished about 50 signs and have about 150 remaining.

The budget is on target. The Fireman's Fund increased \$671.00 from the Chili Cook-off.

The Board will be sending out letters to those with back dues and they will be turned over to collections. Irene Briggs, Lot 210, noted that the resolution regarding Collections and Liens stated the letters were to be sent out by July 1. The resolution will need to be update to be current with Utah law. A few lot owners have contacted the Board with hardships and payment issues. The Board will take this under advisement and set up a possible payment plan. **III. Facilities & Architectural Committee** – John Colman, Chairman; Dan Theisen, Vice-Chairman; Ron Anderson, Charles Duvall, Gina Chapman & Clint Malburg to assist

a. Pond & Fence - Clint

Clint stated in June 500 pounds of fish was planted in the Pond and there was plenty of water at the time. Individuals are still catching good amount of fish. Clint removed the fish food dispenser and collected \$49.75 this year. Clint reminded everyone Utah is a "fence out" state. It is Swains Creek's responsibility to "fence out" the live stock. Clint talked about a section – Swains Creek Road and Swains View Trail - that does not have a fence and explained that the cattle do not currently graze at the site. Clint suggested it would cost about \$8000.00 to \$9000.00 to fence the section. Clint said he and Bob would fix the broken fence lines this year instead of contracting it out. Clint stated there are several gates that were originally installed by Andrew Black's company that need repair. The gates were put in originally installed to lot owners at a cost of \$200.00 and repairs would cost about \$100.00 Clint raised a question regarding a gate that needs repair and lot owner does not want to pay to get it repaired. Clint stated the problem with having the lot owner doing their own repairs, is that the break in the wire loosens the wire down the line. Clint stated there are three gates on Debonair. Paul recommended contacting the lot owner to have the gate repaired the "right way" or the gate will be closed. There have been sheep in the area and Clint and Bob chased them back toward Strawberry.

b. Roads, Parking, Runway & Facilities - Clint

The roads are holding up very good. The majority of the damage is from individuals that do not live in Swains. Clint talked about the road from Swains Creek sign to Highway 14 and stated it is a forest service road and Kane County maintains the road. Charlie offered to contact the forest service about the road and see if they could do any improvements on this road. Clint stated it would be an added cost of about \$10,000.00 to have mag chloride on the road if it was approved by the forest service. However, Clint suggested to have a good road base put down first and not the gravel that was used last year. Clint said the runway was under good condition and another plane landed. Clint talked about trash being put around the bins and not in the bins.
